James Dowthwaite is Junior Professor of English Literature and Culture at Johannes Gutenberg University, Mainz. His books include Ezra Pound and 20th Century Theories of Language: Faith with the Word (Routledge, 2019) and the forthcoming Aesthetic Criticism: An Introduction (Routledge, 2026). Poems, essays, and reviews have appeared, amongst other places, in Acumen, ASAP/I, The Fortnightly Review, The High Window, Literary Imagination, PN Review, Strix, and Poetry Salzburg Review.

Aman Erfan is a PhD candidate in English at the University of Leeds. She has previously worked on contemporary East-Asian literature, and her current research focuses on representations of the fungal in twenty-first-century literature and culture.

Mary Gallagher is Professor of French and Francophone Studies at University College Dublin. Her interest in Caribbean writing (La Créolité de Saint-John Perse, Gallimard, 1998 and Soundings in French Caribbean Writing since 1950, Oxford University Press, 2002) and in translation drew her to Hearn's work and to its French reception. Her short studies on his association with the Creole cultural continuum and with the Creole folktale appeared in American Creoles (Liverpool University Press, 2012) and in The Conte, Oral and Written Dynamics (Peter Lang, 2010) respectively. Her critical editions of the 1920s-1930s French translations of Hearn's Creole writings were published by L'Harmattan (Paris): 'Martinique Sketches', 2 vols (2003); 'A Midsummer Trip to the Tropics' (2004); 'Creole Fantastics and Floridian Reveries' (2023).

Antony Goedhals is Senior Lecturer in the Department of English at the University of Pretoria. He is a generalist and has published on Medieval as Well as Victorian literature, including The Neo-Buddhist Writings of Lafcadio Hearn: Light from the East (Brill, 2020). He teaches a wide range of texts, poetry and prose, from Geoffrey Chaucer to J. M. Coetzee.

Daichi Ishikawa is a Senior Assistant Professor in the Department of Foreign Languages and Liberal Arts at Keio University, Japan. He earned a PhD in English from Queen Mary University of London in 2018, with a thesis on British aestheticism and cosmopolitan notions of curiosity in Walter Pater, John Addington Symonds, and Lafcadio Hearn. His publications include a chapter on Pater's 'Sir Thomas Browne' and its nineteenth-century British context (Routledge, 2017), as well as articles on novelty in Pater's cosmopolitan aestheticism (2022) and on radical idleness in Pater and Oscar Wilde (2023). A chapter on Pater's non finito is forthcoming in a book which celebrates the 60th anniversary of the foundation of the Walter Pater Society of Japan.

Isabelle Lavelle is Associate Professor of Japanese and Comparative Literature in the College of Humanities and Sciences at Nihon University. She earned a PhD in Japanese Studies from Paris Cité University, with a thesis on Dazai Osamu, and a PhD in Communication Studies from Waseda University, with a thesis on the Japanese reception of French decadence. Her research focuses on the displacement and reinterpretation of European Symbolism in Meiji and Taishō Japan. Her recent publication includes a chapter on the translation and canonisation of Verlaine between France and Japan in Textual Heritage: Locating Textual Practices Across Heritage and the Humanities (Berghahn Books, 2026).

Paul Murray is a retired Irish diplomat whose postings include Ambassador to Korea (South and North), and to the OECD and UNESCO. Murray's interest in Lafcadio Hearn was ignited by a posting in Tokyo in the late 1970s. His biography, A Fantastic Journey: The Life and Literature of Lascadio Hearn (1993), was a recipient of Koizumi Yakumo Literary Prize (1995). He edited The Japanese Ghost Stories of Lafcadio Hearn for Penguin Classics (2019). He was awarded the Gold Medal of the Ireland Japan Association in 1999. Following his biography, From the Shadow of Dracula: A

Life of Bram Stoker (2004), he has published extensively on Stoker, including four long-lost short stories, and contributed to Gibbet Hill (2024) and Irish Writers in the Civil Service (2025). He has also written on lesser-known writers such as Frank Frankfort Moore, Ethel Voynich, and Hamilton Deane. Two of his dramas have been performed in Dublin.

Tom Smith is Senior Lecturer in German at the University of St Andrews. His research focuses on modern and contemporary German literature, film and performance, gender and queer studies. His book Comrades in Arms was published by Berghahn Books in 2020. He is an AHRC/BBC New Generation Thinker and regularly presents his work on BBC radio. He has worked as a translator in various contexts.

Cheyenne Symonette is a PhD candidate in English Literature at Michigan State University, where her research explores Victorian and Modernist literature, decadence, and the cultural histories of the circum-Caribbean through works by authors such as Lafcadio Hearn, Zora Neale Hurston, M. P. Shiel, and Rachilde.

Damian Walsh is a PhD candidate in English at University College London and incoming Wilde-Holland Fellow at UCLA's Center for 17th- and 18th-Century Studies.
